

WESTVARS® NET SCRIPT

18:58 hrs. We will be starting the WestVARS ^{*}net in 2 minutes. If anyone needs to use this repeater, please do so now. This *is (Your call sign)*.

19:00 hrs. This is (*Your call sign*) for the WestVARS^{*}net. This net meets each Wednesday at 7pm local time on the WV4ARS VHF FM repeater My name is (*Your Name*) I'm located in (*Your City*) in Volusia County, Fl. I will be your net control for this session. The WV4ARS FM repeater at 147.315 Pl tone of 103.5, is linked to the internet via ECHOLINK Node 887321 and Allstar Node 59840.

Please remember that this repeater takes about ½ second for the PL tone to open the squelch.

This is a directed net. Please follow Net control instructions.

When checking in, please give your call sign slowly and phonetically, followed by your name and location. I will acknowledge after all stations from your area have checked in. If for any reason you need to leave during the session, please inform net control that you are securing your station.

For those stations with 10-meter, 6-Meter and/or 70-Centimeter DMR capability, we conduct three additional Nets after this one:

At 2000 hrs. the 10-meter net starts at frequency 28.315 MHz USB Simplex.

The 6-meter net starts after 10m net. 52.04 MHz FM Simplex And at 20:30 the DMR net starts on the KN4EHC repeater: 442.225 MHz +5 MHz) BrandMeister talkgroup 311679, Timeslot 1, Color Code 1
